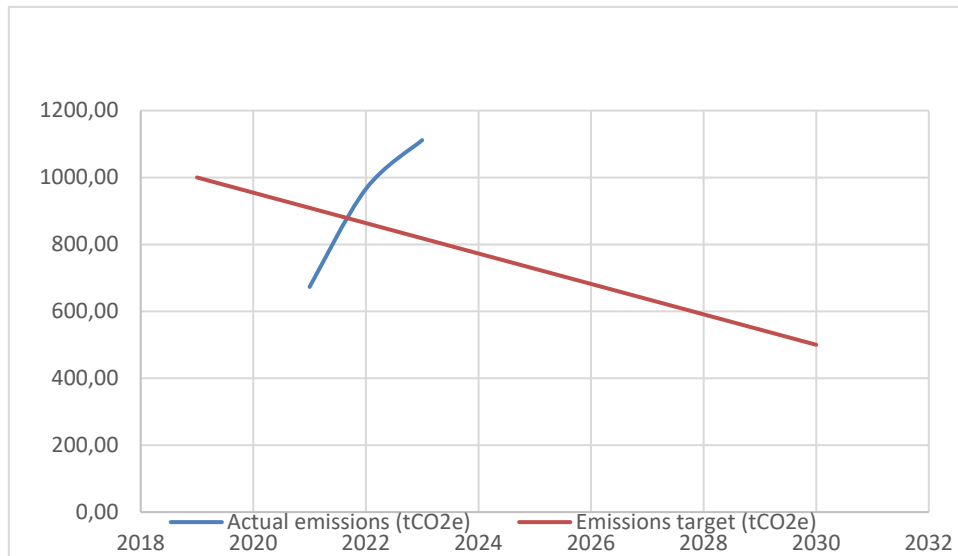
### Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease to 500,05 tCO<sub>2</sub>e by 2030. This is a reduction of 50% compared to a 2019 base year.

We project that emissions will reduce to 681,88 tCO<sub>2</sub>e by 2026. This is a reduction of 32% compared to 2019.

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2019 baseline. The carbon emission reduction achieved by these schemes equate to 324 tCO<sub>2</sub>e, a 32%ge reduction against the 2019 baseline and the measures will be in effect when performing the contract

In the future we hope to implement further measures such as:

- Select tier 1 suppliers with carbon reduction plans and/or adhering to SBTi
- Reduce consumption of high-carbon products and services
- Opt for economy class for long-distance business travel and further reduce travel
- Promote EV/public transport and bike for commuting of employees
- Source renewable electricity in all offices that we lease

## Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard<sup>13</sup> and uses the appropriate Government emission conversion factors for greenhouse gas company reporting<sup>14</sup>.

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard<sup>15</sup>.

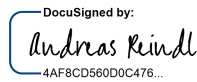

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Van Bael & Bellis (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. ### **Getting paper copies**
